The mission of the Lac qui Parle Soil and Water Conservation District is to take available technical, financial and educational resources, whatever their source, and focus or coordinate them so that they meet the needs of the local land user to help him/her protect Lac qui Parle's natural resources.

YES, people notice erosion in your fields!

We have received several comments from people about the significant erosion and washing of soil taking place this spring. There are conservation practices that can be used to protect your ground, but they have to be in place to provide this protection!

The Environmental Quality Incentives Program (EQIP) provides cost share assistance to install conservation practices where needed. NRCS will be announcing a signup for this program in the near future. Funds must be obligated for projects by the middle of July.

Assess your fields while you are doing field preparations this spring. If you have some spots you would like looked at give our office a call. We can make a field visit to determine eligibility and make cost estimates. EQIP can provide financial assistance for a wide variety of practices including terraces, water and sediment control basins, grass waterways, grade stabilization structures, diversions, and the tile that is needed to make these practices function. The program also can be used to seal old wells, install ag waste systems that correct pollution problems, convert irrigation systems to low pressure, develop wildlife habitat, control invasive noxious plants, and install farmstead windbreaks. You may also be able to earn incentives to adopt practices like no-till/strip till, nutrient management plans, pesticide management plans, prescribed grazing systems, and the conversion to organic production. Don't procrastinate - call or stop at the office for details.

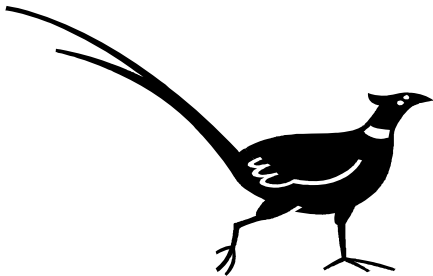
RIM/WRP signup April 20 - June 5

This state-federal wetland restoration program will enhance wildlife habitat, improve water quality, and reduce potential flood damage in targeted areas. Priority is given to the prairie pothole region of the state. Do you have an area you think might fit this program?

WHIP

The Wildlife Habitat Incentive Program (WHIP) is a cost share program to develop wildlife habitat on your land. It can help with approximately 75% of costs to establish native grassland, restore wetlands, and plant windbreaks. It can also be used to manage existing areas of wildlife cover so they are better suited to produce the type of wildlife you want. This could include prescribed burning to protect and preserve native grasslands, control of noxious invasive plant species in woodlots or on grasslands, and/or planting of better grasses to improve upland wildlife habitat. This year's signup will be coming very soon. Stop by the office to discuss eligibility.

The EQIP and WHIP programs may have additional options or higher levels of cost share for applicants that qualify as limited resource farmers, beginning farmers, or applicants that are considered traditionally underserved.



National Volunteer Week April 19-25

NRCS is proud of the dedicated Earth Team volunteers and staff who have committed their time and talents to conserving and protecting our natural resources. In Madison we have several Earth Team volunteers doing things such as rain gauge and stream monitoring, and helping with outreach activities. If you are interested in helping as a volunteer, we likely have a need that matches your area of interest and time schedule! Stop by the office to find out more.

Building a garage, repairing a road, cleaning out an old stand of trees - the Wetland Conservation Act applies to YOU! Before starting work, check at the Environmental Office to see if your proposed project may impact a wetland.

Native Buffer cost share program

We have a program that provides cost share up to 75% to establish and manage 25 species of native grasses and forbs. Eligible land includes cropland, pasture, and land already covered by an easement such as the Reinvest in Minnesota (RIM) Program. The land must then be managed to maintain the diverse stand for at least 15 years.

If the land is not under an existing program, there is an upfront per acre payment which is based on 75% of the CRP annual rental rate which is then multiplied by 3 years. If not restricted by an easement, the landowner has the right to harvest the hay and/or to harvest and sell the seed.

Project types that may work for this program include flood control, well head protection, stormwater treatment (rain gardens, biofiltration, detention areas), and areas where invasive species can be removed and diversity increased to 25 species.

Our ash trees & EAB

Lac qui Parle county's ash trees could be in danger from a small foreign invader - the emerald ash borer, EAB. This insect was discovered in the United States in 2002 and continues spreading to new areas leaving dead ash trees in its wake. The emerald ash borer can fly several miles in a year expanding its range, but it is firewood and wood products taken from infected areas and transported to other locations that enable them to expand their range fastest. They were recently found in western Wisconsin - what can we do to slow the spread of this beetle and keep them from destroying our trees? Do not transport wood! Whether going to your lake cabin or camping at a park, do not bring firewood from home, and don't bring unused wood back home!
